---

Parents desiring to sign up for the DPISA Campus Portal may do so by following these procedures:

1. Complete the DPISA Parent Portal Access Request on the other side of this form.
  - a. The forms and user's manual can be found on the DPISA web site and at the school offices. DPISA's web address is [www.duluthedison.org](http://www.duluthedison.org)
  - b. DO NOT SIGN THE FORM. A SCHOOL EMPLOYEE MUST VERIFY YOUR SIGNATURE AND RIGHTS TO STUDENT DATA.**
2. Take the form to your child's school and sign it in front of a school administrator, office manager, or teacher.
3. After the school administrator, office manager, or teacher verifies your identity and legal rights to student data, they will sign the form.
4. You may download a user's manual from the DPISA Web site.
5. The school office manager will forward all requests to the DPISA technology team. Your activation key will be emailed or mailed to the name and address identified on the form.

Use of the Parent/Guardian E-mail Address:

If you elect to use the **DPISA Campus Portal** to monitor your child's educational progress, only the District and your child's school will use your e-mail addresses to notify you of upcoming events. We are encouraging parents/guardians to utilize this feature as it provides another avenue of communication.

**Accounts will become available in early January 2007 – please feel free to fill out and bring in this form at any time, and we will send you your activation key when the portal becomes active.**
